- **b. Gutters-** Everyone agreed that insulation was a bigger priority than gutters for the Historic Renovations budget.

Other

The following quotes were received from Crowell's Painting and Drywall:

Install the shingles on gable end of the cobbler shop, we supply the shingles (already have them). \$450.

Phil motioned for Crowell's to do this job for \$450 for labor. Connie 2nd the motion. All in favor. Unanimous.

East Wakefield School: Install ceiling tiles (will find closest to existing) Where the ceiling has fallen in and pain to match, scrape area in foyer, patch and paint. \$350

Phil made a motion to accept Crowell's East Wakefield School tile quote. Connie 2nd. All in favor. Unanimous.

Snow Plow: scrape, prime and paint two sides (back and west) build and install gutters on two sides. \$800

Phil made the motion to accept Snow Plow quote. Paul Z. 2nd the motion. All in favor. Unanimous.

Remove all gutters from railroad station. \$600 (I told him we do not want all removed, just the damaged ones. Rick will work it out with him.) Quote was \$600 for all but will be less if fewer areas are removed. This requires renting a lift to do the work.

Phil made a motion for the gutter work to be done for not more than \$600. Nancy H. 2nd the motion. All in favor. Unanimous.

He looked at the freight house but they could not see where the damage is.

Needs to be looked at again as there is possible water damage.

Also the roof of the caboose is leaking perhaps Crowells can apply sealer. These items are to be followed up at Oct. meeting.

Connie T. motioned to adjourn the meeting at 7:45 pm.
