Camper program update

Three students have signed up for Barry Camp. two for one week and one for a mini week. The cost to the Commission for Barry Camp is \$1,035 for the three children. There are five children interested in going to Tanglewood and that would cost the Commission \$2,525. Barry Camp cost \$610 per child and the mini-camp is \$315. Tanglewood is \$625 per child. These costs are before deducting the \$100 deposit per child. This makes the budget line over by \$560. There was discussion on how to fund the additional cost.
