**Amendment 7:** (Article 8) Are you in favor of adoption of Amendment 6 as proposed by the Planning Board for the town's zoning ordinance as follows:

Amend Article 13, Recreational Campgrounds and Camping Parks, by setting a minimum length of water frontage required per cabin or camp site for campground parcels with water frontage. Allow existing campgrounds that do not meet the minimum shore frontage to expand subject to receiving a conditional use permit as allowed by Article 29.

Mr. Stewart said he was good with these changes that were discussed by the Board. The Board concurred.

Mr. Dube opened the Public Hearing for Article 7 at 7:04

Mr. Stewart explained to Mr. Mankus that what is written in red for this article in zoning are the changes the Board made and will be in our zoning if approved by the voters in March.
