WAKEFIELD CONSERVATION COMMISSIONN Adopt - A – Conservation Property Program

Purpose: To allow conservation minded Individuals and or groups to provide care and over site of certain conservation areas.

There are a number of properties up for adoption. If you'd like to volunteer for this project, please contact the Wakefield Conservation Commission and we will help you get started. It is important that you contact us to fill out the application and to understand the conservation easement stipulations as these vary from one easement to another. Also: this is to prevent any duplication of effort.

Adoption involves 3 steps:

Rules and Regulations

1. All adopting individuals or organizations must sign an Adopt-A-Conservation Property Program Application.
2. The Wakefield Conservation Commission will have final approval on all properties adopted.
3. Participants must be at least 6 years of age and children below the age of sixteen (16), must be accompanied by a responsible adult while on the property.
 - A. Take only photos leave only footprints.
 - B. What ever you carry in be sure to carry out.
 - C. Do not litter.
 - D. Promptly report suspicious activities or vandalism to local Authorities and to the Conservation Commission.
4. All organizations must be approved for the Adopt-A-Conservation Property Program.
